

## COMMON-LAW PARTNER – LUMP SUM ON DEATH

If you and your deceased common-law partner were not resident in Denmark and were not registered with ATP as common-law partners, you need to complete this form to request payment of the lump sum benefit from ATP. You also have to fill in the bank information form on page 2. In order for you to qualify for the lump sum benefit, the following conditions must be fulfilled:

- the deceased died no later than five years after the deceased's state retirement age.
- the deceased must have been a member of ATP for at least two years after 1 January 2002, and
- since 1 January 2002, the deceased must have paid the equivalent of two years' full contributions to ATP.
- The lump sum decreases by DKK 10,000 every year from the year after the deceased's state retirement age. The amount will lapse entirely five years after the deceased's state retirement age.

ATP checks whether these conditions are fulfilled prior to payment of the lump sum benefit.

### SHARED ADDRESS

In order to qualify for the lump sum benefit, you also need to provide documentation that you shared **the same address** for the last two years preceding the death of your partner. ### SOLEMN DECLARATION

In order to receive payment of a lump sum benefit from ATP, I, the undersigned, declare by my signature that I and the deceased lived together under marital conditions and that we fulfilled the conditions for entering into marriage or registered partnership during the last two years preceding the death of my partner.

For this purpose ATP can transfer information regarding name of deceased, my name, our address and that we fulfilled the conditions for entering into marriage.
